Location

The property is located on Osprey Road on the Sowton Industrial Estate, Exeter's main distribution location, situated between Junctions 29 and 30 of the M5 motorway, approximately 3 miles east of Exeter city centre. The Sowton Estate benefits from direct access to the motorway, and Junction 29 also provides dual carriageway access to Honiton and beyond along the A30 trunk road.

Description

The Alpha Centre development backs onto the M5 and nearby occupiers include The Nightingale Hospital, Plumb Centre and Gazco.

Unit 1 is detached with dedicated front and rear forecourt and parking spaces. Previously used as a dental workshop the property is laid out as workrooms, offices, meeting rooms, consulting rooms and WCs on the ground and first floors. It is considered that the premises would suit a combination of medical / laboratory uses or warehouse, office or leisure uses (subject to planning if required).
